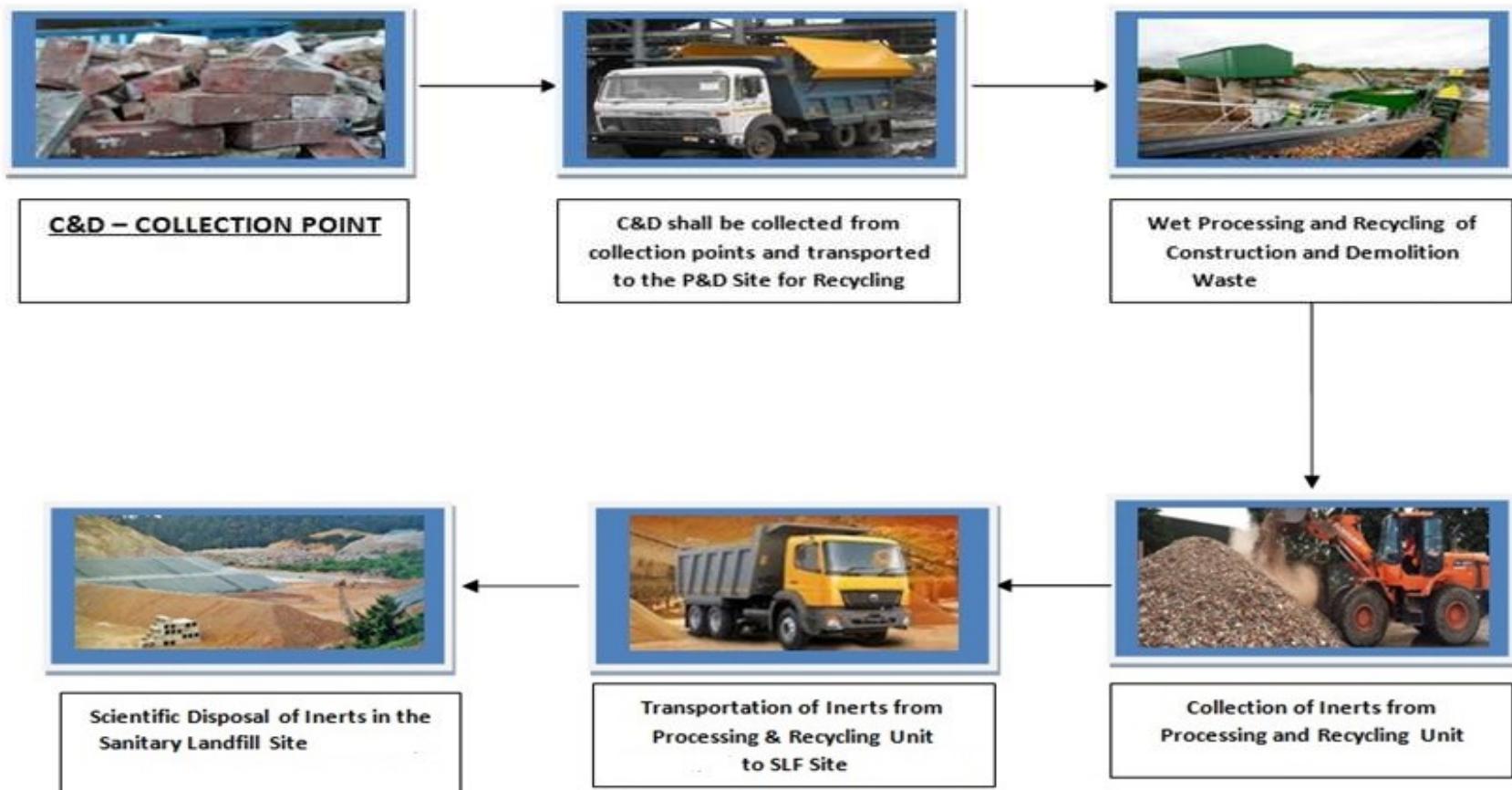

# PROPOSED APPROACH AND METHODOLOGY

- **PROCESSING AND RECYCLING :**

The proposed plant will have a specialized Segregation System, Debris Handling System, Multiple Screening System followed by Material Washing, Sand Washing and Water Management System.



# PROPOSED APPROACH AND METHODOLOGY

- **PROCESSING AND RECYCLING :**



## HOPPER & FEEDER

- Feeding of Material into the hopper, with an initial Screen of 200 mm.



## SEGREGATION

- Separation of Concrete and Bricks.
- Separation of Concrete Blocks over 200 MM in size and stacking them separately.



## CRUSHING / SIZE REDUCTION

A crusher will reduce the size of the concrete blocks to the desired size depending upon the end use.



## FEED CONVEYOR

Feed Conveyor will be used to feed the crushed material to prorate / water rinsing unit.



## SCREENING

Crushed Material will be sent to the Log Washer to separate light contaminants (Wood & Plastics) and to improve quality and to retrieve fine particles

# PROPOSED APPROACH AND METHODOLOGY

- **PROCESSING AND RECYCLING :**



## WASHING UNIT

- Washing unit will consists of Rinsing & Resizing Screens which are used to size aggregates.
- Dry Aggregated will be removed and stockpiled in separate bays.



## FINES RECOVERY

- Washed Sand of -3 mm to +75 Microns will be recovered which is free from any slit.



## WATER TREATMENT

75 Micron material is treated through water specifically chosen flocculent is added to it for formation of condensed sludge.



## FILTER PRESS

Filter Press Section will remove the water from sludge and take 80% of dry solids and drop the solids into a final bay (which can be used for brick making)
